Could an expanded Observatory replace the club room?

This was not the purpose of the proposal made by the feasibility study; it is unlikely that the feasible size would meet our needs.

What communications have we had with SBC Ltd re their financial situation?

We are meeting with them on July 12th, there are has been some informal discussion. SBC Ltd has indicated they will not be able to survive with current income levels for 6 years but this does not consider cash flow.

What is the programme to get the observatory ready for September observing season?

The Curator commented that he has repaired the focusser three times and members have used it in the year, he does not have a machine shop to fabricate items; as all trustees he and those who assist are volunteers with many other calls on their times. It is inaccurate to suggest the observatory is unusable but some equipment has failed. We have other instruments we can use.

The Curator is considering "plan B" options but again there is a risk of failure; solutions need to be designed to fit and forget.
